## **GENERAL INFORMATION**

AQUAFUEL™ EXTREME is a blend of water conditioning agent (ammonium sulfate), surfactants, drift reduction agents and humectants. AQUAFUEL EXTREME contains antifoaming agent to minimize foaming.

AQUAFUEL EXTREME may be used with pesticides that either require or suggest the use of surfactants and/or ammonium sulfate as the recommended adjuvant.

# RATE RECOMMENDATION

AQUAFUEL EXTREME should be used at 1.0% v/v (20 oz/ac at 15 GPA and 13 oz/ac at 10 GPA) to 2.5% v/v (50 oz/ac at 15 GPA and 32.5 oz/ac at 10 GPA).

Do not use at rates above 5% v/v.

Additional adjuvants may be added for deposition, retention and canopy penetration. Always read and follow the specific pesticide label directions, adjuvant suggestions, rates and mixing instructions.

## HANDLING INSTRUCTIONS

AQUAFUEL EXTREME rates may be adjusted for varied herbicides and weather conditions.

Add AQUAFUEL EXTREME to the spray tank first before adding any other tank mix product, unless the tank mix pesticide(s) or additives direct otherwise.

### MIXING INSTRUCTIONS

- 1. Fill tank 1/2 full of water and begin agitation.
- 2. Add the required amount of AQUAFUEL EXTREME while agitating.
- 3. Continue filling spray tank with water and add the tank mix components as directed on the pesticide label(s)

## STORAGE AND DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Product may suspend in layers if stored below 0 degrees F.

Triple rinse (or equivalent) prior to disposal. Add rinsate to spray tank. Offer container for recycling or dispose of properly according to state and local authorities. If burned, stay out of smoke.

## PRECAUTIONARY STATEMENTS

Harmful if swallowed, absorbed through skin or inhaled. Avoid contact with eyes, on skin or clothing. Avoid breathing vapors or spray mist. Remove and wash contaminated clothing before reuse. Wash thoroughly with soap and water and before eating, drinking, chewing gum, using tobacco or using the toilet.

#### FIRST AID

IF SWALLOWED: Call a doctor or poison control center immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything by mouth to an unconscious person. IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. IF INHALED: Move person to fresh air. If a person is not breathing call 911 or an ambulance, then give artificial resuscitation.
